IMPORTANT RULES

1. This card is the property of the Union and is to be exchanged every (12) months.
2. Notify your local secretary whenever you change your address or in case of losing your card.
3. Before you go to work in a new place, take out a working card at our local office.
4. Pay your dues and assessments regularly in the offices of the Union or through the chairman of your shop.
5. Make all your shop complaints in the office of your Union.
6. Attend regularly the local meetings.
7. If you do not receive "Justice" the official publication of the International, notify the Local office, giving your name, address, ledger number and the language of the publication desired.
8. Except in cases where a shorter period is prescribed by the by-laws of your Local Union, the International Constitution provides that a member who is 13 weeks in arrears in the payment of dues or assessments shall be suspended from all rights and privileges. Pay your dues and assessments promptly and preserve your rights to full payment of death benefit.
9. Members who owe 39 weeks' dues are automatically dropped as members of the Union without written notice and may rejoin only as new members.
10. LOSS OF DUES CARD WILL NECESSITATE A CHARGE OF 50c FOR A DUPLICATE.
