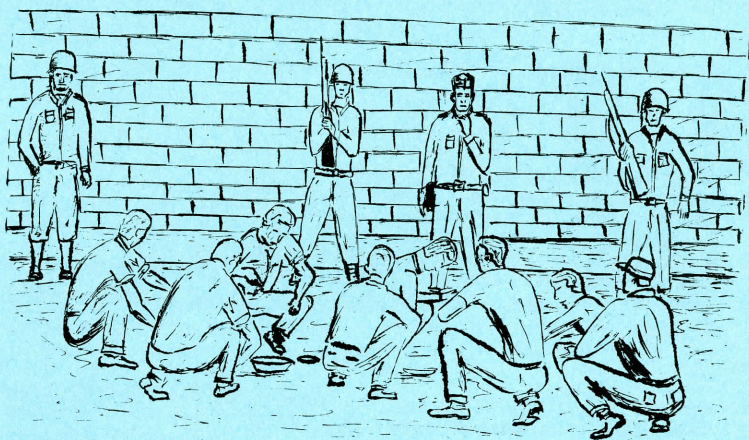


LEXINGTON-CONCORD 1775

TYRANNY in all times and places wears the sanctimonious and hypocritical mask of "law and order". Under the guise of "maintaining order", despots have never failed but to rivet the chains of slavery more tightly on their hapless victims. In 1775, British officialdom, hag-ridden by the alien masters of the Bank of England, ruthlessly tried to force the American Colonies into the same servile mold. The Boston Massacre and other outrages were perpetrated in the name of "preserving the Authority of the Crown." Adolf Hitler carefully amended the postwar German constitution so as to "legalize" his dictatorship. Dachau and Oswiecim were thus utilized to detain and to liquidate, not the enemies of Hitler, but of the so-called Constitution and of the State. Even the unspeakable Josef Stalin and his heirs exhibited a "constitution" under which the Katyn Massacre, the liquidation of the Vlasov anti-communist Russians, the slaughter of the East Germans, and the murder of the "rioters" of Poznan were justified.

WITHIN recent weeks, the governors of the states of Tennessee and Kentucky, under the pretext of maintaining the very Constitution they were in fact destroying, used troops, machine guns, bayonets, and tanks to force Racial Integration upon their unwilling and outraged fellow citizens. Not to be outdone, the Federal Government with its usual illegal meddling, sent in F. B. I. agents to protect the "civil rights" of the Negroes and the traitorous white scalawags involved. Strangely enough, nothing was said about the "civil rights" of the law-abiding white majority, who must now sit back and watch the effects of Integration upon their sons and daughters forceably exposed to the frightening immorality of race mixing with its attendant evils of crime, dope rings, sexual perversion, disease, and vicious riots, such as we have witnessed here in the North for many years.

WHEN the whites, driven to desperate measures to protect themselves and their children, have resorted to the only means of protest left open to them, the governors of the above states in chorus with the entire Internationalist and left-wing press of the nation, have howled and whined and wailed about the "outsiders" and the "agitators" who, they claim, have "stirred up innocent people to violence". One governor has even gone so far, in a desperate attempt to salvage his shattered political career, to declare that the troops were sent in to protect the people from the "outsiders"! However, it was noted that the guns were turned against the citizens and their schools. Isn't it odd that the governors never get around to mentioning the real outsiders in the case, the alien Communists, Jews, and other scum from the ghettos of Eastern Europe who plotted and connived to put Integration over on a confused and divided American public! Let's take a look at just three well documented quotations which show the aims and the identity of the true outsiders in the Integration Controversy:

I.

From the "Jewish World", London, February 9, 1883:

"The dispersion of the Jews has rendered them a cosmopolitan people. They are the only cosmopolitan people, and in this capacity must act and are acting as a solvent of national and racial differences. The great ideal of Judaism is not that Jews shall be allowed to flock together one day in some hole-in-the-corner fashion, for, if not tribal, at any rate separatist objects but that the whole world shall be imbued with Jewish teachings, and that in a universal Brotherhood of Nations---a greater Judaism, in fact---all the separate races and religions shall disappear...."

II.

From "A Racial Program for the Twentieth Century" written in 1912 by the Jewish Communist Israel Cohen:

"We must realize that our Party's most powerful weapon is racial tension. By pounding into the consciousness of the dark races that for centuries they have been oppressed by the whites, we can mold them to the program of the Communist Party....In America, we will aim for a subtle victory. While inflaming the Negro minority against the whites, we will endeavor to instill in the whites a guilt complex for their exploitation of the Negroes. We will aid the Negroes to rise to prominence in every walk of life, in the professions and in the world of sports and entertainment. With this prestige, the Negroes will be able to inter-marry with the whites and begin a process which will deliver America to our cause."

III.

From "The Review and Forecast", by Dr. John Slawson, Executive Vice-President of the American Jewish Committee, page 631 of the American Jewish Year Book, Vol. 57, 1954:

"Earlier, I said that the desegregation decision of the Supreme Court was one of the major events of the year affecting our work. This historic ruling is a significant

high water mark in America's battle against discrimination on racial, religious, and ancestral grounds--a battle in which the American Jewish Committee has long been among those leading the assault.

"It was most fitting, therefore, that we were very closely involved with the Supreme Court decision. Not only were we active, along with other organizations, in the filing of an amicus brief, but we contributed materially to the social theory upon which the desegregation decision was based. The ruling, you know, gave great weight to sociological and psychological factors. The Court took into account, along with purely legal considerations, the effect of segregation on personality, and concluded that separate facilities cannot be equal because of the psychological damage caused by segregation."

IN the above quotations, all the viciousness, underhandedness and hypocrisy of the Supreme Court's Desegregation Decision is revealed. According to information released by Senator Eastland of Mississippi, the Court's decision was based NOT upon the Constitution, but upon the contrived lies and loaded statistics of a coterie of Communists, Fellow Travelers, and professional South-haters, under the leadership of a radical Swedish Socialist named Gunnar Myrdal. This contemptible conspirator was quoted in the Saturday Evening Post as having described the adoption of the United States Constitution as "nearly a plot against the common people! The compilers and co-authors of Myrdal's book, "An American Dilemma" belong to some 63 known Communist and Communist Front organizations. These men, says Senator Eastland, "contributed to 272 different articles and portions of the book officially adopted by the Communist Party and by the Supreme Court as its authority for its racial integration decision of May 17, 1954."

IT is almost superfluous to add that the NAACP, the chief catspaw and agitator in the present situation is amply financed, staffed and directed by Jews, Communists, and Fellow Travelers. The Jew, Arthur Spingarn president of the organization belongs to at least one known Communist Front. The records of some of the other leading lights in this gang are: Congressman Adam Clayton Powell, Jr., 66 Communist Fronts; Attorney Thurgood Marshall, 5 Communist Fronts; Exec. Secy. Roy Wilkins, 6 Communist Fronts; Dr. Ralph Bunche, 7 Communist Fronts; W. E. B. DuBois, 72 Communist Fronts; Hulan E. Jack, 16 Communist Fronts; Channing Tobias, 50 Communist Fronts; Rabbi Stephen H. Wise, 15 Communist Fronts; Senator Herbert Lehman, 10 Communist Fronts; Walter A. White, 12 Communist Fronts; Alfred Baker Lewis, 6 Communist Fronts; Benj. E. Mays, 1 Communist Front; Allan K. Chalmers, 2 Communist Fronts; Mary McLeod Bethune, 50 Communist Fronts; Algernon Black, 20 Communist Fronts; Wayne L. Morse, 1 Communist Front; Hubert T. Delaney, 10 Communist Fronts; Eleanor Roosevelt, 53 Communist Fronts; and, Walter Reuther, listed 45 times in Index V of the Un-American Activities Committee. To top the whole matter off, one of the Supreme Court Justices before whom NAACP Counsel Thurgood Marshall pled his case, was none other than former NAACP Director Felix Frankfurter, Zionist Jew, and sponsor of the convicted perjurer Alger Hiss!

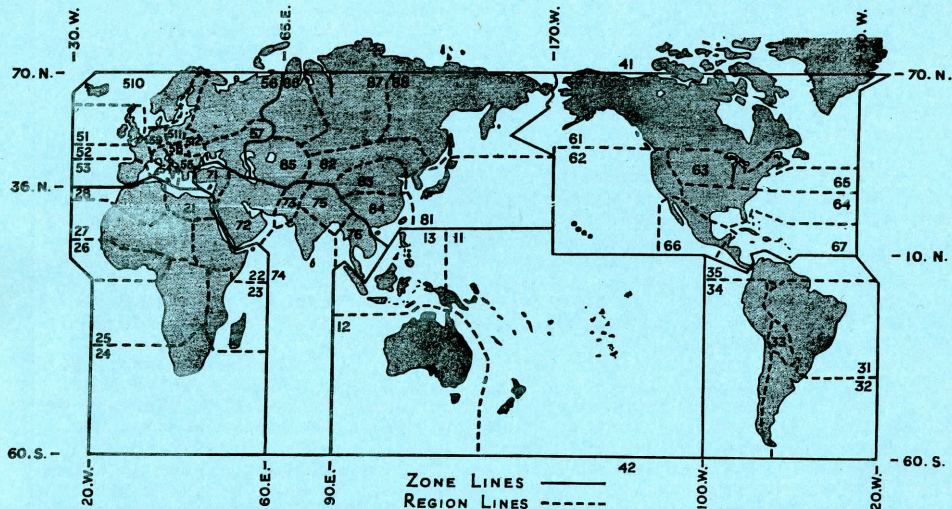
BRITISH journalist Douglas Reed writes in "Far and Wide":

"For the South, for the present American Republic, and possibly for the entire white family the Civil War remains of present significance. More Americans were killed in it than in both twentieth-century wars together. Not only for that reason is it a living American reality, whereas the others were more quickly forgotten. Brother fought against brother in it and never knew for what. Few now believe it was fought to free slaves...The fury of partisanship, on either side was used to different ends....

"It was the first war in which the lot of a third party (and not the aboriginal population) was employed to divide white men against each other in the new worlds they thought to have conquered, and to promote a worldwide revolutionary design. The real aim was to break the political power of the rural South and transfer it to the expanding industrial North, where the revolutionary forces were the strongest. (After the war)...power passed, not to Northern Americans of the old stock, but more and more into the hands of newcomers (ie. the hordes of East European Jew immigrants, Ed.)....They brought with them schemes for a new Union; that of the world, with America and all other countries servient to it. Like the Republic's tombstone (it has that shape) their headquarters building was rising in New York when I went there; it was called the house of 'The United Nations'....

"I think the road to the American Civil War, and beyond, clearly ran from the French Revolution. Today the war against the South continues. It is indispensable to the politics of New York and of the tomb-stone building. Crushed in 1865, the South is still too strong. With that obduracy which attends God's processes, it has remained homogeneous, a surviving obstacle to the consolidation of the new power in America and in the world.... The transference of power to a newly arrived minority is...possible if the original stock can be kept fairly equally divided by the wedge of some exterior issue....For this purpose the negroes of the South continue to be used....The Southern negro thus plays in the 1950's, as in the 1860's, the part of stalking horse in the pursuit of political power..."

THUS it can be clearly demonstrated that the objective of the Internationalist Jew and his Communist and high Masonic allies, is the destruction of America's freedom and sovereignty, and her subjugation under the iron heel of the United Nations or some other International force. To accomplish this, it is first necessary to destroy the South. Just how far this diabolical plot has proceeded is shown by the below map which was distributed by the World Association of Parliamentarians for World Government in London, England, in September of 1952. Region 64 on the map is to be occupied by the Soviet Red Army, and so it is clear that if the South cannot be enslaved by local or Federal troops, so-called United Nations forces will be called in.



TAKE a long look at the sketch at the beginning of this leaflet. It was taken from a wirephoto of free American citizens, seized and held illegally and against their will for exercising rights guaranteed under the Constitution.
