
This is a warning. Please read carefully.

Should you wish to return to the United States you must write this office or the American Consular Office nearest your residence abroad as to how to obtain permission to return after deportation. By law (Title 8 of United States Code, Section 1326) any deported person who returns without permission is guilty of a felony. If convicted he may be punished by imprisonment of not more than two years and/or a fine of not more than \$1,000.00.

WARRANT OF DEPORTATION

To any Officer or Employee of the United States Immigration and Naturalization Service.

After due hearing before an authorized officer of the United States Immigration and Naturalization Service, and upon the basis thereof, an order has been duly made that the alien BOLESLAVS MAIKOVSKIS

who entered the United States at NEW YORK, NEW YORK

on or about the 22nd day of DECEMBER, 1951, is subject to deportation under the following provisions of the laws of the United States, to wit:

Section 241(a)(1) of the Immigration and Nationality Act and Section 241(a)(19) of the Immigration and Nationality Act.

I, the undersigned officer of the United States, by virtue of the power and authority vested in the Attorney General under the laws of the United States and by his direction, command you to take into custody and deport the said alien pursuant to law, at the expense of the

appropriation "Salaries and Expenses, Immigration and Naturalization Service, 1984", including the expenses of an attendant if necessary.
