

WHO ARE THE WAR CRIMINALS ?

The letter quoted below was sent to Lord Wright. The statement of Prof. Laski reads : " This war is in its essence a stage merely in an immense revolution in which the war of 1914, the Russian Revolution and the counter-revolutions on the Continent are earlier phases." Everyone should know by this time that the Russian ' Revolution ' was plotted and carried out by International Jewry, and it follows from the statement that the two wars and the Nazi and Fascist ' counter-revolutions ' were planned by the same people.

The statements by Sir Stafford Cripps are :

(1) " If war comes, as come it may, that war has to be used for the destruction of capitalism. It will have to be used by the workers in this country to undermine the whole system."

(2) " The war is a stage in the efforts of the peoples of the world to readjust themselves to new economic and social conditions, and, in that sense, it must be revolutionary in its effects on our civilisation." (From address to British Association Conference.

The ' Jewish leader ' referred to said to Sisley Huddleston and others (see *In My Time*) : " When Hitler comes to power I hope he will persecute the Jews We thrive on persecution."

Letter to Lord Wright :—

My Lord,

You are reported in to-day's *Daily Telegraph* as saying that one of the functions of the Commission was to trace the crime from the actual perpetrators to the central mind or authority, such as Hitler or Goering. If you are not going further back than to such people, then your whole procedure will be a sham, and the most damnable deception imaginable of the peoples of the world. Why? Because you will have ignored the momentous statement made by Prof. Harold Laski in *The New Statesman* of 11 July, 1942, which is quoted in the enclosed leaflet " What the Jews Say"

Whether Laski wrote this in an unguarded moment, or defiantly—knowing that the British people were sufficiently tame, or asleep, not to ask questions—is beyond me. It tallies with Disraeli's statement that the Jews intend to destroy Christendom (see *Lord*

George Bentinck, ch. 24), and with Walther Rathenau's statements that 300 men, known only to each other, govern the fate of Europe (*Neue Freie Presse*) and that this century would be the century of destruction (*Der Kaiser*).

Please note also the quotation below the one from Laski's article. Undoubtedly the Jewish leader concerned meant that he and his fellows would see that Hitler *did* persecute the Jews, to say nothing of other people.

Hitler, Goering and Company, though of course entirely unaware of it, were mere puppets in the hands of the world's seducers, destroyers, incendiaries and executioners, as Dr. Oscar Levy described his people.

The survivors of the Nazi leaders should be closely examined with a view to the exposure of the plotters of the war. It has often been written that German re-armament was financed partly by people in this country and the U.S.A. It is more important that such people be laid by the heels than the puppets above referred to. (Lord Norman might be a useful witness in this connection). Puppets can always be recruited by lies, flattery, appeal to ambitions and so on. Sir Stafford Cripps should be called as a witness to explain his two statements enclosed herewith.

A word on 'collaborators' may well be added. First of all, anyone whose execution is demanded by Communists should automatically be set free without a stain on his character. Remember that the French Communists in the first months of the war were shouting "England is the enemy."

A collaborator may be excused for having regarded Hitler as a genuine champion of the Gentile world against the Jewish Power ("our terrible power of the purse" as Theodor Herzl put it) and for failing to realise that that very Power had manoeuvred him into the leadership of Germany and was egging him on in all his actions, even to persecuting its own racial rank and file.

It is the duty of the British Government to bring the utmost pressure to bear on the French authorities to release Marshal Pétain. How could that unfortunate old gentleman, who is infinitely more of a patriot than any of his accusers, have been anything but bewildered by events? Any error of judgment on his part is no reason at all why he should be treated as a criminal. If he is harmed in any way, it will constitute an indelible stain on this country's honour as well as that of France. Our honour has already been sullied by countenancing the murder of M. Pucheu and of more recent victims.
